Ancient Civilizations and Cultural Resources

Instructions for Contributor (as of 9 May 2023)

Guidelines

- 1. This online journal aims to promote the study of ancient civilizations, cultural resources, and related fields all over the world by integrating the arts and sciences.
- 2. The submitted contributions must be original and unpublished. The corresponding author must be a member of the Institute for the Study of Ancient Civilizations and Cultural Resources, Kanazawa University, or someone with a recommendation from the member.

Formats of Papers

- 1. Manuscripts must be written in English or Spanish including title, abstract (not exceeding 150 words in length), 3-5 keywords, text, acknowledgement, figures, and tables (with their captions), notes, appendices, and references. Manuscripts should be written in a standard Unicode font such as Times New Roman, in 11-point or larger type. Manuscripts can be any length. There are no restrictions on word count, and the number of figures and tables.
- 2. Notes must be endnotes rather than footnotes. Also, notes are referred to in the text with a superscript number. Where notes are included, they must be numbered sequentially in the text using Arabic numbers in superscript. For citations within the notes, follow the rules below.
- Names, words, phrases, and so on originally written in scripts other than Latin should be transcribed or transliterated into the Latin script, except in cases where it is deemed necessary to present the original script.
- 4. Figures (photographs, maps, and other illustrations) and tables should be embedded in the manuscript for the first submission.
- 5. If authors are finally invited to proceed to publication, they will be requested to submit the main text, any figures and tables, and a list of figures and tables with their captions, each as a separate file. The figures for publication should be sent electronically formatted as image files (e.g., jpg., tiff.) ideally in resolutions of 300 dpi for photographs and 600 dpi for other illustrations. Each figure and table should be formatted within a page size of 15.5 × 21.0 cm. These will be published online in color.
- 6. Authors are responsible for obtaining any permission needed to publish their figures in printed and online formats.

Submission of the Manuscripts

- 1. The author should e-mail a Microsoft Word document (or text file) of the manuscript along with a PDF file of the manuscript (an online storage site should be used if the total size of the files exceeds 10 MB; a separate notice should also be sent via e-mail).
- 2. There are no submission deadlines. Submissions are reviewed, edited, and uploaded online (free open-access downloads) at any time. However, the complete annual issue is closed and published at the end of December. For the annual issue, manuscripts (of the first submission [see above]) must arrive no later than October 31st each year.
- 3. The cover letter accompanying a manuscript should include the following: the names of the author(s), the institutions to which they belong, and their titles; the corresponding author's address, telephone number, and e-mail address. Author(s) who plans to be away from their usual address during the evaluation and publication period should provide an alternate address, phone number, and e-mail.

Peer Review of the Manuscripts

- 1. Editorial board selects potential reviewer(s) based on their expertise in research areas. Reviewer(s) evaluates the paper based on such criteria as the importance of the subject, the clarity of the writing, and adherence to the format guidelines.
- 2. Based on the reviewer(s)' evaluation, the editorial board decides whether the paper is accepted without revision, with major revision, with minor revision, or rejected.
- If a manuscript needs major or minor revision, the editorial board asks the author(s) to revise the
 manuscript. Then the revised manuscript is accepted by the editorial board or goes through the
 second round of peer review.
- 4. If a manuscript is rejected, the editors notify the author on their reasons for doing so.

Publication of the Manuscripts

- 1. The corresponding author of a paper receives the proofs. The author is responsible for checking the proofs of the manuscript and making necessary corrections. Changes must be limited to the correction of typographical errors; substantive changes to the text are not permitted at this stage. The author does not receive copies of the revised page proofs.
- 2. The PDF file can be used strictly for personal, noncommercial, or scholarly use under the

following terms and conditions:

- Institute for the Study of Ancient Civilizations and Cultural Resources, Kanazawa University retains the copyright for all papers published in the journal.
- In order to reproduce all or a part of the PDF file in a publication or other work, the author(s) must obtain the written consent of the copyright holder in advance.
 - The author(s) may print out the PDF file.
 - The author(s) may send the PDF file on a storage device or by e-mail to other individuals.
 - The author(s) may post the PDF file on a website, blog, or SNS.
 - The author(s) may not modify the PDF file without the consent of the copyright holder.
